Substitution – Measure Package SWWH027-03

1. Discussion and Direction

The California Public Utilities Commission (CPUC) approves the statewide measure package for Heat Pump Water Heater, Commercial, Fuel Substitution – SWWH027-03. This is a revision to an existing measure package SWWH027-02. The measure package was updated in accordance with Resolution E-5152. SWWH027-03 will become effective on January 1, 2023. Measure package SWWH027-02 will be set to expire on December 31, 2022.

2. Measure Package Summary

The measure updates were in response to Resolution E-5152 to update the measure package for PY2023. This measure package meets all fuel substitution guidance document requirements.¹

Key updates include:

- Updated measure offerings to reflect new efficiency requirements and storage capacities
- Added data collection requirements per Resolution E-5152.
- Updated material, labor, and infrastructure costs per Resolution E-5152.
- Updated measure package with DEER Water Heater Calculator v5.1 impacts.
- Added measure load shapes corresponding to DEER Measure Tech IDs
- Updated refrigerant avoided cost calculations (RACC)
- Updated fuel substitution calculations
- Updated measure impact type to account for DEER measures
- Updated pre-existing tech types
- Updated eligible building types and eligible building vintages

3. Critical Review Issues

Reviewers confirmed that all updates were completed in accordance with CPUC policy and guidance. The Ex Ante Review team had minor comments for Southern California Edison (SCE) requesting minor text edits, the most up-to-date references, and permutation updates to align with DEER Water Heater Calculator v5.1 values. SCE has addressed the review comments in full and the Ex Ante Review Team recommends measure approval.
