**SECTION 6 – TERMS AND CONDITIONS**

1. I am a Property Owner or the Property Manager, as authorized agent for Property Owner, of a residential multifamily property with an active service account(s) served by SCE. I understand that I am only eligible to receive rebates for qualified products purchased and installed in residential multifamily properties powered by service from SCE. Multifamily properties are defined as residential apartments, condominiums, mobile home parks, single-room occupancy (SRO) facilities, and single-family homeowner association (HOA) communities. **New construction does not qualify.**
2. Only qualifying Integrated Programmable Variable-Speed Drive (VSD) Pool Pump(s) replacing existing single speed pool pump are eligible for rebates.
3. I certify that the qualified energy efficiency products were completely installed between January 1, 2018 and December 31, 2018. Completed applications must be received by January 30, 2019. I further understand and agree that upon the installation of the replacement pool pump, the existing equipment will **NOT BE REFURBISHED AND/OR RE-SOLD.**
4. Terms of this rebate offer may be modified or terminated without prior notice. This Program will end on December 31, 2018, or earlier, if all allocated funds are depleted before that date, or if terminated by SCE or the California Public Utilities Commission (CPUC).
5. I understand the qualifying product(s) must be installed by an SCE-authorized contractor. All uses herein of the words “install”, “installation” or similar phrases shall mean complete installation such that the subject products are fully functional.
6. I understand and agree that the choice of the energy-efficient product(s), selection of SCE-authorized contractor and work performed are my sole responsibilities. I waive any and all claims against SCE, its parent company, its directors, officers, employees, affiliates and authorized agents (“SCE Parties”), and will indemnify the SCE Parties for any claims arising out of or relating to the installation, use, quality, and/or safety of the energy-efficient product(s) referred to in this Application. **I ALSO UNDERSTAND THAT SCE MAKES NO WARRANTY, WHETHER EXPRESSED OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTY OF MERCHANTABILITY FOR ANY PARTICULAR PURPOSE, USE, OR APPLICATION OF THE PRODUCT(S) REGARDING MANUFACTURERS, DEALERS, MATERIALS, AND WORKMANSHIP.** Without limiting the generality of the foregoing, none of the SCE Parties shall be liable for any type of damages, whether direct, indirect, incidental, consequential, exemplary, reliance, punitive or special damages, including damages for loss of use, regardless of the form of action, whether in contract, indemnity, warranty, strict liability or tort, including negligence of any kind.
7. I am responsible for complying with any applicable state/county/city government, property owner, and/or homeowners’ association requirements (if any) regarding permits, local conditions, restrictions, codes, ordinances, rules, and regulations pertaining to all installations. I further understand that it is my sole responsibility to ensure all products are installed in accordance with all manufacturers’ specifications.
8. I agree that SCE has no liability whatsoever concerning the quality, safety or installation of any energy-efficient product, including its fitness, workmanship, or any other matter.
9. I agree to allow SCE’s representative and/or a CPUC representative reasonable access to verify the installed products. I agree to this inspection in order to be eligible to participate in the program and receive a rebate for the qualifying product(s). I understand this inspection is for the purpose of determining that the installed product meets all program(s) requirements.
10. SCE may disclose information from my response to the CPUC, as required by the CPUC.
11. I understand that I cannot receive energy efficiency rebates for the same product, or for the replacement of an installed product, from more than one California Investor-Owned Utility or other third party programs offering rebates, financing and other incentives funded with CPUC Public Goods Charge funds.
12. I understand that recirculation and purification systems must be operated in accordance to California Code of Regulations, Title 22, Chapter 20, Public Swimming Pools, Dicta 65525 which states that pumps, filters, disinfectant and chemical feeders, flow indicators, gauges and all related parts of the pool water purification system shall be kept in operation whenever the pool is available for use, and at such additional times and periods as may be necessary to maintain the water in the pool in a clear and disinfected condition. The variation in flow during a filtration cycle shall be such as to not reduce the flow below 65 percent of the rate required in Section 9032 of Title 24, California Administrative Code.
